Goods and services tax registration notice
For your information

You are now registered for goods and services tax (GST) purposes. The details of your registration are:

GST registration number*	: 48 820 489 422
Date registration takes effect	: 1 July 2011
GST tax periods	: Annual
GST accounting method	: Cash

*Your GST registration number is the same as your Australian business number (ABN).

As your GST tax periods are annual, you must lodge a GST return with us each financial year.

Your GST return will form part of an activity statement that is issued towards the end of the financial year. The due date for lodgment of the annual GST return is either:

- the due date for lodgment of your income tax return, or
- 28 February if you are not required to lodge an income tax return.

You must check your eligibility to report annually on 31 July each year. You must notify us if on this date:

- your projected GST turnover* is greater than or equal to the registration turnover threshold (\$75 000, or \$150 000 for not-for-profit entities);
- you are required to be registered for some other reason, even though your turnover will be less than the threshold, or
- you wish to change your tax period.

We will then change your tax period to monthly or quarterly.

*Your 'projected GST turnover' is the value of all supplies that you make, or are likely to make in the current month, plus all the supplies that you are likely to make in the next 11 months. However, you only include those supplies that are made for consideration, are connected with Australia and are not input-taxed - you disregard all other supplies.

If you fail to comply with any of your tax obligations, we may disallow your election at any time.

Wine equalisation tax, luxury car tax and fuel tax credit

If you indicated on your application for registration that you may have obligations under the wine equalisation tax, luxury car tax or fuel tax credit legislation, you will be contacted at a later date for further details.
